<u>PFAS TESTING RESULTS -</u> The village received good news from the DNR officials reporting on our recent PFAS testing for all three municipal wells. Laboratory procedures allow testing down to parts per trillion levels, with the Village of Amherst municipal water found to have no measurable levels of PFAS in tests run by the State Lab of Hygiene. <u>FIREWORKS REMINDER -</u> As the 4th of July approaches, questions often come our way involving the use of fireworks within the Village of Amherst. There are a limited number of items legally defined as "fireworks" in Wisconsin and Village Ordinance Chapter 12.01 (G) reflects Wisconsin Statutes 167.10(1) regarding these. Possessing or using any other types of fireworks is illegal in Wisconsin without a valid permit per Wis. Stat. § 167.10(3). Generally speaking, a permit is required to discharge a device if it explodes or leaves the ground. Should you feel that fireworks are being discharged illegally within the village, immediately contact the Portage County Sheriff's Department at 715-346-1400.
